**Abbreviation Used:** Unreserved (UR), Other Backward Classes (OBC), Scheduled Castes (SC), Scheduled Tribes (ST) & Economically Weaker Sections (EWS).

**NOTE:-**

- i. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Bibinagar reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules / circulars and requirements.
- ii. In case suitable Economically Weaker Sections (EWS) candidates are not found, these posts will not be carried forward/or considered as backlog vacancies. Therefore, candidates, including those who do not belong to the Economically Weaker Sections (EWS) category, who are eligible to apply against UR post may apply for posts earmarked for EWS.
- iii. Reservation will be as per Government of India Policy.

**2. UPPER AGE LIMIT: 45 Years (As on last date of submission of application)**

- a) "The **cut- off date** for determining the maximum age limit, essential qualification & experience, for payment of fee, etc., is 23.02.2026 up to 05:00 PM."
- b) The relaxation in age shall be as per Government of India norms and the maximum permissible relaxation
  - i) SC/ST candidates 5 years
  - ii) OBC candidates 3 years
  - iii) Persons with Bench-mark Disabilities [PWBD] General Category 10 years
  - iv) Persons with Bench-mark Disabilities [PWBD] OBC Category 13 years
  - v) Persons with Bench-mark Disabilities [PWBD] SC/ST Category 15 years
- b) **To be eligible for selection** for these posts, the candidate should pass the qualifying examination as on **cutoff date** & result should be declared to this effect on or before this date.
- c) **The candidates who are in service in any Government Institutions are required to submit No Objection Certificate (NOC) from the employer at the time of interview.** The candidates will not be permitted for interview if they fail to produce no objection certificate on the day of interview during scrutiny of documents.

**3. PAY SCALE**

- (i) For **Medical** candidates Pay Level 11 of Pay Matrix as per 7th CPC with entry pay of Rs. 67700/- + NPA plus other usual Allowances, as applicable
- (ii) For **Non-Medical** candidates M.Sc. with Ph.D. Pay Level 10 of Pay Matrix as per 7th CPC with entry pay of Rs. 56100/- plus other usual Allowances, as applicable

**4. A. RESERVATION FOR SC/ST/OBC/PwBD/EWS SHALL BE APPLICABLE AS PER GOVT. OF INDIA POLICY.**

Reservation for Persons with Bench-mark Disabilities Candidates (PwBD) is applicable by Govt. of India Policy, which will be provided on horizontal basis to PwBD candidate in their respective categories.

**Criteria for Persons with Disabilities Candidates:**

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions and counter signed by Medical Superintendent / CMO / Head of Hospital / Institution.

**Candidate applying in EWS/OBC/SC/ST Category must possess the caste certificate issued by competent authority, valid for admission/Job in Central Govt. Institutions issued before the date of interview, failing which he/she shall not be allowed to appear in interview for the same category. However, he /she can be treated as UR Candidate.**

OBC certificate must have been issued within one year of last date of application. .i.e. issued after 01.04.2025 and before the cutoff date Candidate should belong to non-creamy layer of Central List of OBC.

In case candidate fails to produce valid OBC certificate for admission/Job in Central Government Institution at the time of interview / document verification otherwise, he/ she may be treated as UR Candidate.

**4. B. RESERVATION FOR ECONOMICALLY WEAKERS ECTIONS (EWS):**

Persons who are not covered under the scheme of reservation for SC's, ST's and OBC's and whose family has gross annual income below ₹8 lakh (Rupees eight lakh only) are to be identified as EWS's for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application. Such candidates should have valid income certificate on the date of application in the prescribed format or on the letter head of the

issuing authority to this effect before filling the application and submit the same at the time of document verification, failing which their candidature will be rejected. ## ANNEXURE “A”- TERMS & CONDITIONS

1. **Tenure:** - The appointment for a period of 89 Days or up to next regular Interview, whichever is earlier. This appointment will not vest any right to claim by the candidate for permanent absorption in the institute OR for continued contractual appointment, which may be renewed or terminated as decided by the Institute based on the evaluation of performance of the candidate.
2. **Remuneration:** -The appointment will entitle the appointee to remuneration as per pay-scale.
3. The leave entitlement of the appointee shall be as per the Central Residency Scheme and Institute Policy.
4. The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
5. The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.
6. This appointment is fulltime and private practice of any kind is prohibited.
7. He/ She will have to work in shifts and can be posted at anyplace/Center attached in the Institute as per the discretion of the MS/Dean/Executive Director. Competent Authority of this Institute reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
8. He / She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.
9. No travelling or other allowances will be paid to the candidate for joining the post.
10. The candidate should not have been convicted by any Court of Law.
11. Canvassing in any form will render the candidate disqualified for the post.
12. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he/she will be liable to be removed from services and such action as the appointing authority may deem fit.

14. The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard. The decision of the committee shall be final and binding.
15. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
16. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
17. Candidates working in Govt. / Semi-Govt. PSU should apply through proper channel. The candidates in-service will not be permitted for examination / interview, without "No Objection Certificate" from the employer. The post will be on tenure engagement for a period of maximum 89 days, including such engagement earlier if any should not be more than the prescribed period for SR ship (if you have already served as Senior Resident in previous appointment the same will be calculated along with the present engagement at AIIMS, Bibinagar).

22. Senior Residents under active bond period are eligible for appointment only subject to production of valid NOC or bond clearance certificate.
23. The recruited Senior Residents may be assigned to work in one or more departments, depending upon the availability of vacancies and institutional requirements. All Senior Residents will need to work in emergency on rotation as needed.
